1. The running of Leg 1

1.1.- Report on driver N. 11 illness.

The driver of car N. 11 asked for medical care before the start of yesterday Free Practice / Qualifying Stage.

He was examined by CMO who was present in the Stage. The driver (Chris INGRAM) presented symptoms of fever, tiredness, sweating. He realised the stage with no more novelty.

In the afternoon he feel bad and goes directly to local Hospital.

The CMO was requested by CoC to follow the evolution and the course of events directly with hospital's doctor.

The CMO informs that the driver, has been examined in the hospital and realised different analysis to assess the constants.

The patient was treated with antipyretics and serum for rehydration.

The first tests denote a possible problem of liver deficiency and the doctor's hospital requires more tests.

In the morning of 4<sup>th</sup> May 2018, the driver feels well, better than yesterday, and asked the Hospital for a voluntary release (enclosed copy of voluntary Hospital release).

On the arrival at the Rally HQ, the patient was evaluated by the CMO. He presented no fever, no significant clinical indications but CMO recommends to follow the tests procedure to arrive to a formal diagnosis.

The CoC makes phone communication to consult with FIA Doctor, M. Jean DUBY, acting as translator for the event CMO.

The doctor asked if the driver has fever this morning and/or a significant clinical indications that could support a "non allowed to start" indication.

Crew N. 11 starts Leg 1.

CoC follows the sporting evolution of team in the SS and their performance.

Nothing important to report.

Performances of car N. 11 on Leg 1: 16<sup>th</sup> in QS, 13<sup>th</sup> in SS1, 18<sup>th</sup> in SS2, retires for illness in SS3).

#### 1.2.- SS 2 " San Mateo"

In order to guarantee the safety of the SS, the start for the 1<sup>st</sup>. car was delayed 4 minutes.

#### 1.3.- SS 3 "Artenara"

At 13:17 h. Race Control receives report of accident of car N° 60. We stopped the running of the Stage and send Medical car and Ambulance to the place.

Car  $N^{\circ}$  61 ( the last of the FIA rally was not affected by the accident ). Enclosed report of the CMO concerning the attendance and care of the crew.

#### 1.4.- TC 8A, 8B and 8C

It was preview several TC at the arrival to Las Palmas from the last stage (SS8) and before the Flexi Service.

At the arrival ( TC 8A) it was preview a Technical Zone of 10 minutes with two Time Controls as stated in article 2.23 of FIA regulations.

After this exit control, cars enter in Parc Fermé for the scheduled FLEXI SERVICE of 45 minutes.

Because of an error, there were not installed the Time Control to check the exit of the Technical Zone and the entrance of Parc Fermé for the Flexi Service.

Time Control TC 8B is cancelled.

1.5.- Report of injuries of accident of car N°. 60.-

1<sup>st</sup> Report: Vertebral bone fracture of co-driver car N° 60: Miguel Ángel GONZALEZ (enclosed CMO report).

After received the CMO reports - who goes to the Hospital on 05/05 on night after the rally – and receives direct information from the Doctor in charge:

- The CMO informs that the patient has vertebrae L1 compressed ( not displaced) without neurological damage or sensivity damage.
- It is planned surgery (possibly on Monday) to stabilize the spine and relieve the compression.
